"See Something, Say Something" Program	Baker informed the Board that the See Something, Say Something program is an anonymous reporting system that allows users to submit secure tips to help at-risk people before they hurt themselves or others. The program provides the students with a phone number to call 24 hours a day, 7 days a week to report a tip.

Approve Mask Policy Update	Chad motioned, seconded by Colleen that in accordance with SB 654 Section 10, Classical Charter Schools of America has reviewed the current mask policy and the schools will continue with a mask optional policy for the month of December. The motion also states that each school will continue to monitor their COVID-19 cases and quarantines and if the quarantines exceed 5% of the individual school's population that school will go back to a mandatory mask policy. The motion was unanimously approved.
