Attendance

• Absence, Excused and Unexcused

All children are expected to be at school each day unless they are ill or there is an emergency. In compliance with the North Carolina Compulsory Attendance Law (G.S. 115C-378) all absences require parental documentation explaining the child's absence.

Three Unexcused Absences

A notification will be sent to families when a student has missed 3 days of school without valid documentation, such as a doctor's note.

Five Unexcused Absences

A second notification will be sent if a student reaches 5 days of undocumented absences, meaning no documentation has been submitted from a healthcare practitioner.

Ten or Mmore Uunexcused Aubsences

Willmay result in a meeting with school administration and could ultimately result in a parent being referred to the District Attorney's office and the Director of Social Services in the county in which the child resides.

Fifteen or More Total Absences

It is the policy of the Classical Charter Schools of America Board of Trustees that any student with more than 15 absences (excused or unexcused.) may be retained the following school year. Parents may appeal this decision if a medical condition exists which may have prevented normal attendance.

Twenty Five or More Total Absences

If a student misses a combination of <u>25</u>twenty-five excused or unexcused absences, he or she may be returned to the traditional school system and can reapply the following school year.

Submitting Absence Documentation

If your child is absent from school, please send a note or email to your child's teacher stating the reason for the absence. Notes should be received at school no later than 2 days after the absence.

- No more than ten school days per semester will be excused based on parent notes.
- Future absences due to personal illness, injury, or medical/dental appointments will require a healthcare practitioner's statement or court documentation to be excused.
- Undocumented absences cannot be excused.

Students who are absent for family, church trips or other reasons not considered excused by state policy will be given an unexcused absence. Work may be provided ahead or made up upon return if cleared with an administrator before the absence occurs. In certain cases, travel for an educational purpose may be excused. Requests for absences for an educational opportunity should be submitted, in writing, to School administration at least five days in advance of the anticipated absence. The request should include the learning objective of the opportunity and how the objective links to educational standards.

These absences are excused but still count in the maximum number of days allowed. School work missed during approved educational leave, as well as the grade specific travel assignment, are due to the teacher within one week of return. If work is not submitted, the absences may be coded as unexcused.
